Course for Candidate Airline Pilots

1. Introduction of the Course

The CPL (A) Conversion «**from ICAO to EASA**» Course is designed to convert an ICAO or FAA license to an EASA one.

The possibility is given to the candidate to obtain an EASA License by attending a Conversion Course and the basic training in accordance with the EASA Part-FCL regulations.

This Course is aimed at training pilots who have already attended their pilot training in another Country that is not located in Europe and does not operate in accordance with EASA.

The course is designed to equip students with the skills, knowledge, and experience needed to operate as a pilot in command of an aircraft in commercial operations under EASA regulations.

2. Pre - entry requirements:

- Current - Valid ICAO CPL/IR/MEP
- EASA Medical (Class 1) Certificate
- ICAO Language Proficiency Level 4 (at least) issued by an EASA Approved examination centre
- **Before the Skill test the applicant shall meet minimum:**
- 200 hrs total flight time (on aircraft)
- 100 hrs as PIC, 50 of them X-C
- One X-country trip 300 NM as PIC
- ATPL Theoretical Knowledge successfully completion of the examination under EASA examination Center

3. The CPL(A) Conversion Course includes:

▶ **Registration**

- Administration for all required procedures by HCAA for one pass only
- License issuance fee

▶ **TOEFA**

- English Proficiency test

▶ **Theoretical Knowledge Training for MEP**

- 05 hours Theoretical Training

▶ **Theoretical Knowledge Training for PBN**

- 04 hours Theoretical Training

▶ **Theoretical Knowledge Training for UPRT**

- 05 hours Theoretical Training

▶ **Flight Training 15 hours**

- 03 hours on SEP for UPRT
- 03 hours on MEP
- 09 hours on FNPT II (5 for IR and 4 for PBN)

▶ **Skill tests for all ratings of license**

- Up to 02:30 hour on MEP
- 01 hour on PBN
- Examiners fee

▶ **Duration for the Course**

- The duration for this Course is 10 working days

4. Price and Payment Method
